- Please contact the Park Como Ski Center at least one day prior to arrival to confirm space availability. Any team that shows up for a practice without a confirmed reservation may be asked to leave.
- NOTIFY BUS COMPANY - Once buses are unloaded, move bus to the Como Park Lakeside Pavilion North Parking lot, (directly across Lexington Parkway) until ready to reload.
- Your students and athletes are the ambassadors of your school. As coaches, you are responsible for their behavior. During practices, they are sharing the trail with the public. They WILL model the same trail courtesy we expect from any user. Any misuse of trails or vandalism of our facilities by team members or spectators will result in the school losing all use privileges for the remainder of the season with no refund of fee.
