The Minnesota Amateur Sports Commission had expressed an interest in developing a similar type of facility. We need to include them in conversations to determine if there is a partnership opportunity.

Action Items

- 3) Create a grass roots campaign to help equip champions which will also help build additional support within the fundraising and lobbying categories.
- 4) Find key contacts at the nearby Battle Creek elementary school, St. Paul Parks and Recreation Rec Center, and neighborhood council
- 5) Find key contact at the MN Amateur Sports Commission and meet with them to discuss possible partnership opportunities.

Meeting Notes & Action Items:

Operational Needs / Considerations

- 1) Is Ramsey County going to add to their maintenance employee staffing? Feeling that staffing is not adequate now and will need to be increased if area is built. Work determine how many more maintenance hours will be needed if we are going to build the winter park.
- 2) Parking
 - Need to conduct a parking inventory. Who owns the current lots?
 - What are the city of St. Paul's plans now and do they have any plans for expansion?
 - What would be needed for parking if we were to build out the lot?
 - What are alternative sites for parking? Could we use Battle Creek elementary school for parking? Could we use BC waterworks lot with a shuttle for parking?
 - Compare what Elm Creek and Highland have for parking vs. what we have
- 3) Sledding / Tubing / Skiing
 - Would need to contract with a vendor to provide equipment. Check into the Como model for renting / supplying equipment. Get operational info from Como as well.
 - Explore different operational models Highland has just Nordic. Elm Creek has Nordic plus tubing and downhill.
 - What are the facility / infrastructure repercussions for adding tubing / skiing? Might make it difficult to host cc-ski events if the race staging area is taken up by tubers and skiers.
- 4) Data that's been requested / Suggestions
 - Build the winter park in phases adding cc-skiing first then tubing and downhill
 - Get picture of demographics of people who ski versus tube versus downhill ski

- 5) Site development issues
 - What was the determining factor with the location of the reservoir?
 - What is the projected cost of the water? Assume we have to buy all from City of St. Paul?

Funding for Annual Operations

- 1) User fees will be collected to fund annual operations
 - Who will enforce paying user fees?
 - How are the fees established?
 - What are the effects of DNR grant money for reimbursement on trails if fees collected?
 - How much will Ramsey County be willing to cover for annual operating expenses?
- 2) Fee structures
 - Look at school permit fees. Race fees.
 - Review Highland and Elm Creek fee structures
 - St. Paul Park and Rec may cost share on some things

Other Items

- 1) Security concerns
 - Concerns over the security of user vehicles in parking lots. Will video surveillance be provided?
 - How will the snow making equipment be secured?
- 2) Additional parking concerns
 - Neighbor considerations for overflowing streets with parking
 - Any sites on turf to park cars either on park side or City of St. Paul side
- 3) Alternative locations for the entire operation
 - What about the TCAAP site?

Action Items

- 1) Work determine how many more maintenance hours would be needed if we build the winter park.
- 2) Need to conduct a parking inventory
- 3) Identify alternative sites for parking
- 4) Check into the Como model for renting / supplying equipment. Get operational info from Como as well.
